SECTION 5 Fire-fighting measures

5.1. Suitable extinguishing media

Suitable extinguishing media : Dry chemical, CO₂, or water spray or regular foam.

5.2. Specific hazards arising from the chemical

5.3. Special protective actions for fire-fighters

SECTION 6 Accidental release measures

6.1. Personal precautions, protective equipment and emergency procedures
